



## Terms and Conditions for Salontraining.com Membership

Welcome to **www.Salontraining.com** (referred to as "the website" or "our platform"). These terms and conditions (referred to as "Terms") govern your use of the membership platform provided by Salontraining.com (referred to as "we," "us," or "our"). As a valued member, we want to assure you that if our packages go up, you will only be charged the original agreed-upon price of \$4.99 for 12 months during the first contract period. After this initial 12-month period, and as part of this limited time offer, you will have the option to choose whether you would like to renew your membership at the new price. If you decide to renew, a new contract will be provided to you. However, if our price remains the same, your membership will automatically renew without the need for additional action on your part.
