

Trainer Agreement

The Pennsylvania Beauty Pro's Expo - 2025

This document is an agreement made in good faith that you, the Trainer, commit to presenting class(es) at the Salontraining.com Beauty Industry Show - Pennsylvania - at Seven Springs Mountain Resort on one or both of the following dates: Sunday, May 18, 2025 and Monday, May 19, 2025.

As the event gets closer, the exact time(s) and your classroom(s) will be sent to you in the itinerary. This will go out on or before April 15, 2025.

Salon Training LLC reserves the right to accept or reject Trainer Applications at their sole discretion. This decision will be based on availability, skillset, and experience.

The Trainer will be responsible for providing all materials needed for their class, including but not limited to any handouts, computer, USB drive, signage, etc.

Classrooms will be reserved for sixty minutes for each trainer. The classrooms will include a table, monitor to display, HDMI cable, Apple adapters, a table, for those that would like to do slideshow presentations. Microphones will be available in the majority of the classrooms based on the size of the rooms. For a few of the smaller rooms microphones may not be present, as they are not needed. Laptops will not be available for use so you must bring your own, unless you choose to rent one from us. If you rent one from us just bring your back up or if you have google drive you can sign in (remember to have your password ready). In the event your computer does not hook up right away to the venu's system there will be a reference guide on the table to show you how to hook up your computer to their monitor as well as 1 person to assist that will be on the classroom floor (that person will be floating between rooms). If you would like to hire a tech person for your classroom you may do so for the fee of \$60.00per hr and they will be there to fully support you. Contact Tracey Napotnik Via text at (814)248-8928 before Jan, 31, 2025 if you would like to add a tech person solely for your room. Trainers release Salon Training LLC for any issues that may arise from a computer not connecting or any unforeseen circumstances to technical errors to your classroom. Salon Training and the Venu will work to do our best to give you the best possible setting and equipment for your classroom. Participants do not need to register before entering classrooms; as they are free to enter any classroom throughout the event.

Trainer shall assume responsibility for any damages arising or related to trainer's actions.

Except as otherwise outlined in this Agreement, Salon Training LLC shall not be liable for any

loss or damage sustained by the Trainer due to the performance of services.

In the event Salon Training LLC materially fails to perform any services as required by the Agreement or otherwise breaches its obligations under this Agreement, the Trainer's sole and exclusive remedy in connection with any such failure is to allow Salon Training LLC, in Salon Training LLC's sole and absolute discretion, to: (i) within a reasonable period of time, remedy the deficiencies identified by the Organization to the extent remediable.

Notwithstanding any other terms in this Agreement or otherwise, neither party shall have any liability to the other for special, direct, indirect, incidental, consequential statutory, punitive, or exemplary damages of any nature whatsoever, including without limitation, damages related to loss of profit, loss of income or revenue, loss of goodwill, even if it has been put on notice of the possibility of such damages.

Without limiting or expanding the provisions of any of the sections of these terms and conditions, in no event shall either party's liability for monetary damages exceed the amount paid or received for the services with respect to which such liability arose. Trainers and their affiliates pay for their own transportation to and from the venue. They are also required, if staying, to provide their own hotel rooms. The classrooms are purchased by Salon Training LLC to be used by the Trainers at no cost to Trainers. (This does not include the use of the extra hands on classrooms).

The parties acknowledge and agree that the provisions of these Terms and Conditions that limit liability or exclude consequential damages or other damages or remedies are essential terms of and are fundamental to the parties' understanding regarding the allocation of risk. Accordingly, such provisions shall be severable and independent of any other provisions of this Agreement and shall be enforced to the fullest extent permitted by law.

Without limiting the generality of the foregoing, each party agrees that all limitations of liability and exclusions of damages or remedies shall remain fully and valid, effective, and enforceable under their respective terms, even under circumstances that cause any exclusive remedy to fail of its essential purpose. The limitations contained in this Section apply regardless of the form of action, including actions in contract, tort (including negligence), and strict liability. Notwithstanding the preceding, the limitations in this Section do not apply to third-party claims subject to indemnification or any claims arising out of deliberate misconduct or gross negligence.
